## GENERAL

### BASIS

#### 1. PURPOSE AND SCOPE

The purpose of this Tariff: To regulate the fees and application conditions of the port services to be provided at the port of ÇEŞME operated by ULUSOY ÇEŞME LİMAN İŞLETMESİ A.Ş. within the principles specified in the Law, Regulations, Regulations and Instructions.

#### 2. GENERAL PROVISIONS

### BERTHING ORDER OF SHIPS TO BERTHS AND PIERS

As a general rule, the order of berthing and mooring of the ships to the piers is arranged according to their arrival time to the harbour.

The establishment may decide to give priority to ships when necessary due to the characteristics of the ship or cargo. In case these decisions and changes are permanent, the situation shall be announced to the relevant persons in advance by the establishment.

In case of disagreement about the order of arrival of the ships, the information given in writing by the local Harbour Master shall be taken as basis.

### MOORING AND MOORING PLACES OF SHIPS

Vessels to load and unload shall moor to the places determined by the Port Regulations, By-Laws and Instructions and to be shown by the management. The work requests of the ships that do not comply with this rule are not met.

### BERTHING AND MOORING CAPABILITY OF BERTHS AND PIERS

Whether the piers are suitable for berthing and mooring of ships belongs to the management.

### FULFILMENT OF WORK REQUESTS

The work request must be made in writing at least one day before the day on which the service is to be performed until 15.00 at the latest on the official working day (10.00 on the eve days). Requests to be made after 15.00 are accepted as if they were made the next day. All responsibilities arising from the failure to make the work request on time belong to the requestors.

## PROCEDURES RELATED TO CUSTOMS DOCUMENT (SUMMARY DECLARATION)

For all kinds of goods, passengers and tourists arriving and departing to and from the port, it is obligatory to submit a summary declaration to the Enterprise by the ship captain, agents or carriers. The following principles are applied in the submission of summary declarations.

Passenger and Tourist Ships: Passenger summary declaration or list must be submitted to the Company within 6 hours following the arrival time of the ship for ships arriving at the port and within 24 hours at the latest following the departure time for ships departing from the port.

In addition, passenger lists must be approved by the Customs Directorate, Customs Enforcement Directorate or Passport Police.

## FALSE STATEMENT

The Company has the right to investigate the accuracy of the information in the documents that are the basis for the fee accrual submitted by the business owner to the Company in the work requests related to the services in this Tariff book. If a difference is detected according to the document in the investigation made by the Company, the wage difference caused by the misrepresentation in the wage accrual is taken with an addition of 100%.

In case the mistake is corrected before the determination made by the business (except for the goods that should not be taken to temporary storage places), the above additional fees are not applied.

## RESPONSIBILITY

The master or agents of the ship and the owners of the goods, their representatives or those acting on their behalf shall bear all kinds of liability arising from their failure to comply with the applicable legislation and the procedures and principles specified in this Tariff or from their defective acts, and they accept and undertake that they are jointly and severally responsible for the payment of all fees accrued in accordance with the Tariff.

## FEES

The fees stated in this Tariff book are non-tax fees. The charges for the services in this Tariff book are specified in the relevant Service Tariffs and the principles regarding the determination, accrual and collection of these fees are shown below.

### Wage Unit:

The unit of the fees for the services in this Tariff is **US Dollars (\$)**. VAT will be applied to the service items in the tariff according to the legislation.

### From whom the fees will be collected:

Fees for the services specified in this Tariff are collected from the requester requesting the service, unless otherwise stipulated in the Tariff.

## NON-PAYMENT OR LATE PAYMENT OF WAGES

Other service requests of those who have not paid the fees accrued for the performance of the services shall not be fulfilled unless their debts to the enterprise are fully paid.

The cost of these invoices shall be paid within 7 days from the invoice date. In case of non-payment within this period, a delay penalty at the rate of 25% (twenty-five) per month for the first 30 (thirty) days from the invoice date, and for each subsequent 30 (thirty) days, the delay increase rate in the provisions of the Law No. 6183 on the Procedure for Collection of Public Receivables is applied. This provision is also applied to receivables due to differences that may arise after accrual.

In case the last day of the above-mentioned payment periods coincides with a holiday, the period shall be completed on the business day following the last day.

## PROVISIONS NOT SUBJECT TO TARIFF

In the event that a service not included in this Tariff book is requested and this request is fulfilled by the Operator, the fee for this service; If there is a similar service included in this Tariff book, it is determined by comparison, if not, the cost is taken into account by the Operator and determined according to the economic conditions of the day.

- 1- On national holidays and general holidays, pilotage services are applied with 50% increase.
- 2- The pilotage and exemption rates that ships are obliged to comply with are determined by harbour regulations and instructions.
- 4- In case of shifting from one berth to another berth, pilotage fees are applied with 50% discount.
- 6- Çeşme-Gerence / Gerence-Çeşme navigation pilotage service is applied with 2 times additional.
- 7-Çeşme-Gerence / Gerence-Çeşme navigation pilotage service is applied with 4 times additional.
- 8- Çeşme-Gerence / Gerence-Çeşme navigation pilotage service is applied with 6 times additional.
- 9- Service fees for Turkish flagged vessels are applied with 20% discount. However, ships operating on the cabotage line cannot benefit from this discount.
- 10- Pilotage service fee is increased by 20% for Ro-Ro and Ro-pax vessels carrying dangerous cargo.
- 11- Due to force majeure such as weather opposition or situations that may endanger navigation, life, property, environmental safety and security, pilotage service fees are applied with a 50% discount in case the ship leaves the docks, buoy facilities or piers and then docks at the place where it departed, and if it is not possible to dock at the place where it departed, it docks at another dock deemed appropriate by the port authority within the boundaries of the port.

- 1- Tugboat services are applied with 50% increase on national holidays and general holidays.
- 2- For Towage Services, the number and power of tugboats required shall be applied as specified in the Ports Regulations in force.
- 2- The towage fee given to ships that cannot move with their own propeller or cannot maneuver due to a malfunction in the rudder or any other reason is charged with an additional 50%.
- 3- Towage services are applied with 50% increase on national holidays and general holidays.

3- Service fees for Turkish flagged vessels Tugboat service is applied with 20% discount.

However, ships operating on the cabotage line cannot benefit from this discount.

5- In case the tugboat is purchased as an escort tugboat to be used in maneuvers, the escort tugboat fee is applied with a 50% discount.

6-Tugboat services are applied with a 20% increase for Ro-Ro and Ro-pax vessels carrying dangerous cargo.

7- Due to force majeure such as weather opposition or situations that may endanger navigation, life, property, environmental safety and security, if the ship leaves the docks, buoy facilities or piers and then docks to the place where it departed, if it is not possible to dock to the place where it departed, if it docks to another dock deemed appropriate by the port authority within the boundaries of the port, tugboat service fees are applied with a 50% discount.

8- In the event that the ships and watercrafts that cannot move with their own propeller for any reason are towed with a tugboat, the towage service fee is increased by 50%.

1- Mooring services are applied with 50% increase on national holidays and general holidays.

2- Mooring service fees are accrued as double charges, separately for berthing an unberthing maneuvers.

3- Mooring service fee given to Turkish flagged vessels is applied with 20% discount. However, ships operating on the cabotage line cannot benefit from this discount.

It is applied with a 20% increase for Ro-Ro and Ro-pax ships carrying dangerous cargo.

4- Mooring service fees are applied with 50% discount in the event that the ship leaves the docks, buoy facilities or piers due to force majeure such as weather opposition or situations that may endanger navigation, life, property, environmental safety and security, and then berths at the place of departure, and if it is not possible to berth at the place of departure, berths at another berth deemed appropriate by the port authority within the boundaries of the port.

Failure to comply with the above-mentioned 24 hours rule will result in a penalty of 100% of the total landing fee.
